INITIALS CONDITIONS:

- **Work is for educational purposes only.** Only work that, in the sole discretion of the Automotive Technology department, complements class instruction will be accepted.
- The College retains the right to refuse admittance of any vehicle/equipment.
- The College will not work on dilapidated vehicles or abandoned vehicles.
- No vehicle/equipment will be serviced or repaired:
 - If the sole purpose of said repairs or service is for resale.
 - If the vehicle/equipment is associated with a business or other profit-making venture.
- A **\$35.00** shop fee, plus parts and sales tax, will be charged for all repairs.
- **ALL WORK MUST BE PAID FOR AT CASHIER'S OFFICE BEFORE VEHICLE IS RELEASED TO OWNER, UNLESS AN EMPLOYEE PAYROLL DEDUCTION HAS BEEN ARRANGED AND THE APPROPRIATE DOCUMENTATION COMPLETED.**
 - **All work that is estimated by the Automotive Technology Department to exceed \$500.00 requires a \$100.00 deposit.**
- If the item to be repaired is a vehicle, all items which are not securely or permanently mounted to the vehicle must be removed.
- Proof of ownership must accompany this request for repair. Proof of ownership may be in the form of a photocopy of either the current vehicle registration or the vehicle title.
- The institution will evaluate, prioritize and schedule requests. Owners will be notified in advance of the disposition and schedule of requests.
 - Due to instructional needs, absolutely no guarantee will be provided for a timeframe for work to be completed. Any estimates of time needed for completion of work will be tentative only. Owner understands and agrees that students will be working on his/her vehicle, during times scheduled by instructor(s) that meet instructional needs.
- Kaskaskia College is a non-profit education institution. The customer acknowledges that the repair work specified herein will be performed by students and is being performed at a rate that is less than what would be charged at a non-instructional repair facility. Kaskaskia College makes **no warranties**, either expressed or implied, concerning the quality of work performed pursuant to this agreement. The customer accepts his/her automobile and work performed by Kaskaskia College as is.
